Final External Auditor Report and Certificate 2017/18 in respect of Coleshill Town Council WA0063

Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with Proper Practices which:

- summarises the accounting records for the year ended 31 March 2018; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and does not provide the same level of assurance that such an audit would do.

External auditor report 2017/18

On 28 September 2018 we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2018. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review.

The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The smaller authority has not addressed the 'except for' matters raised by the external auditor when qualifying the prior year annual return. Last year, the external auditor stated that un-presented cheques of £6,566 and unbanked cash of £30 were incorrectly treated as debtors and creditors, as well as including them on the bank reconciliation. The correct figures should have been restated in the prior year column of this year's AGAR. Boxes 3, 6 and 7 should have been restated to £169,800, £479,526 and £379,001 respectively. This would also have the effect of amending the brought forward Box 1 figure for the current year to £379,001.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.:


- Section 2, Box 2, the annual precept, does not agree to the figure published by the precepting authority. The figures in Boxes 2 and 3 should read £235,396 and £171,754 respectively. All grants, including Council Tax Support Grant, should be shown in Box 3, as per the guidance notes on the AGAR
- The smaller authority has confirmed that the Coleshill Elite Account of £5,177 has not been included within the accounts in Section 2. This means that Boxes 3, 7 and 8 should increase by this amount.
- Section 2, Box 8 includes long term investments in the CCLA Property Fund. The balance in respect of this account should not be included in Box 8, but instead included as part of the Box 9 figure. Only the original purchase of the investment should be included in Box 6 in the year of purchase.

Other matters not affecting our opinion which we draw to the attention of the authority:

The smaller authority has not provided bank statements as at the year end date to support all the accounts on the bank reconciliation to Section 2, Box 8. These were requested as part of our intermediate review procedures.


