Notice of continued borehole monitoring from June

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM. In your area, we are working near the A452, A45 and M42, which surround the site of the new Interchange Station.

We're preparing for our future works

In the coming months, we need to monitor a number of boreholes which we dug last year in your area. Monthly monitoring will allow us to take samples and measure water levels that the holes have collected. The results will help us plan our future works by telling us the condition of the land. To conduct these safely, we need to undertake a number of overnight lane closures.

We'll start monitoring on 10 June

To carry out this work, we'll need to put in place overnight lane closures, three evenings per month, from June to October 2019. On these evenings, we'll be closing the same lanes on the same two sections of road (see maps on next page). Our working hours will be 9pm to 6am.

We have planned overnight lane closures

We are planning temporary overnight lane closures on:

- 10, 11 and 12 June
- 8, 9 and 10 July
- 5, 6 and 7 August
- 2, 3 and 4 September
- 30 September and 1 and 2 October

Dependent on our sample findings, not all of the lane closures listed above may take place.

Duration of work

From Monday 10 June to Wednesday 2 October.

Working hours will be 9pm to 6am, but our contractors may be on site up to an hour before and after those times.

What to expect

Temporary overnight single lane closures on two sections of road.

Closures will be undertaken for three evenings per month.

What we will do

Keep all sites safe and secure.

Ensure clear signage is in place to inform drivers.

Leave the area in a tidy state when works are complete.

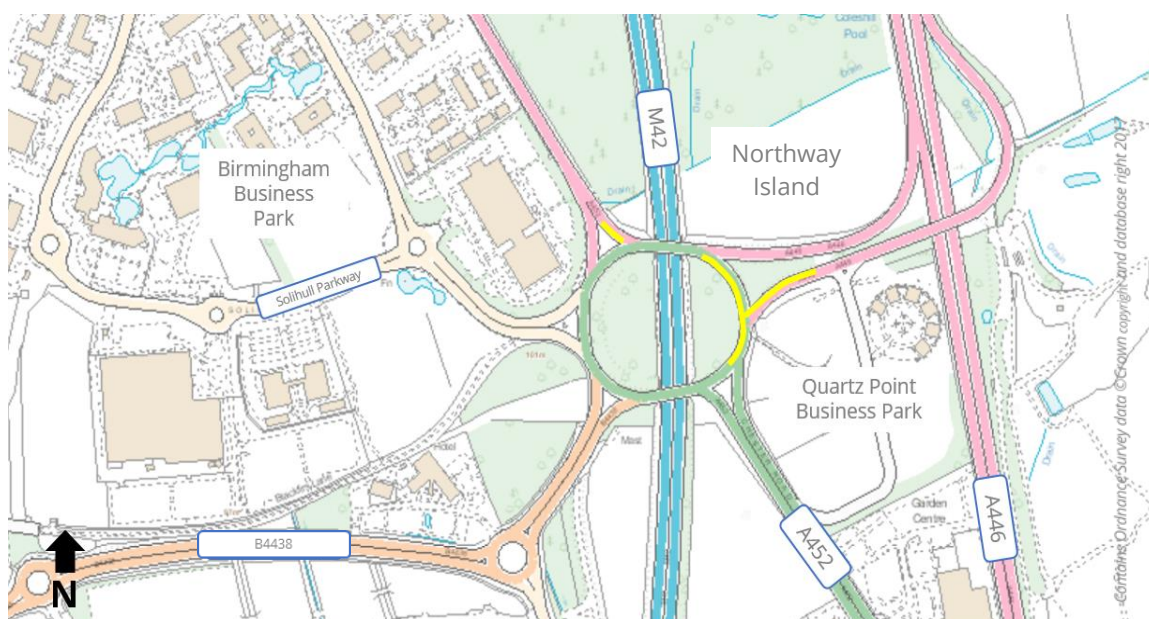
Location of overnight lane closures in your area

Key:

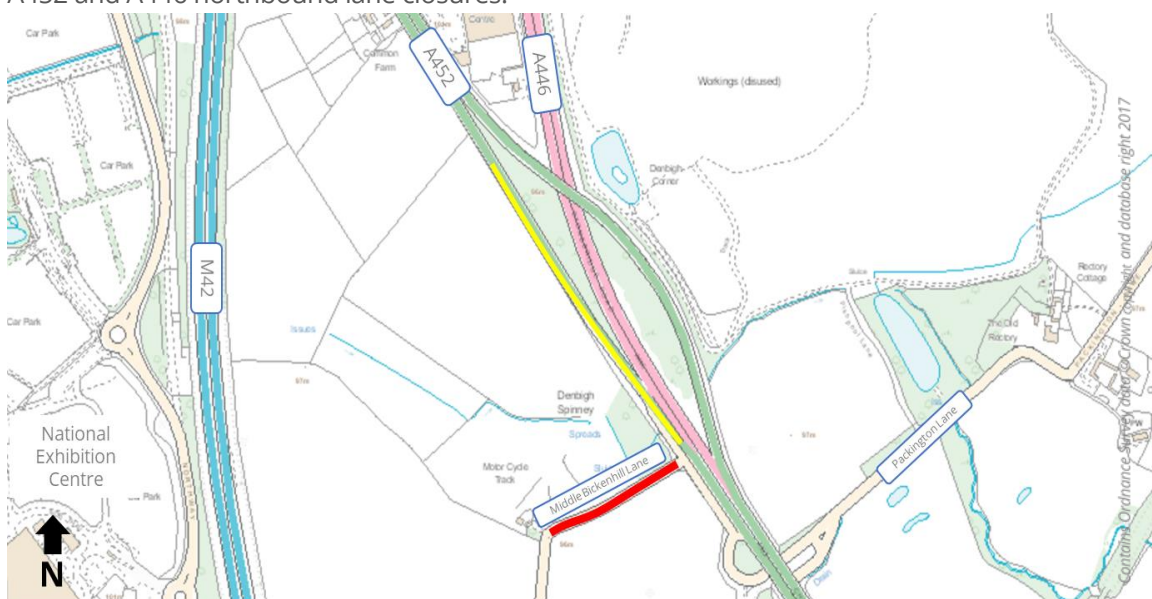
 = temporary overnight lane closures
