Notice of ongoing road and lane closures on the A452 and A446

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM. In your area, we are working near the A452, A45 and M42, which surround the site of the future HS2 Interchange Station.

We're diverting an existing gas main

To help us divert an existing gas main near the A452 and A446, we are continuing with a number of road and lane closures to protect our workforce, and the travelling public, while we work.

We're creating a new access road

Whilst diverting the gas main, we have also been creating a new access road located off the A446 northbound to service a future compound. This road will tie into the existing road network and connect to haul roads on HS2 land, for the exclusive use of our construction vehicles. This new route, as well as those completed off the A452 and B4438, will reduce the requirement for traffic management in the future and help to alleviate congestion.

Our works have been extended until 15 December

To carry out our works safely, we will continue to operate temporary traffic management on the A446 northbound until Sunday 15 December. This will continue to include:

- Overnight road and lane closures (see map on page 2)
- 24/7 lane closures (see map on page 3)

Signed diversion routes are in place for road closures. There are designated road and lane closure times, but our contractors may be on site up to an hour before and after those times. Vehicle and pedestrian access to businesses, including Melbicks Garden Centre, will continue to be maintained throughout our works.

Duration of work

Ongoing works until Sunday 15 December.

Overnight working hours will be 8pm to 6am, but our contractors may be on site up to an hour before and after those times.

What to expect

Overnight road and lane closures for a few evenings at a time.

24/7 lane closures throughout our works.

What we will do

Keep all sites safe and secure.

Ensure clear diversion signage is in place.

Leave the area in a tidy state when works are complete.

Maintain building access.

We have planned overnight road closures

We will carry out overnight road closures on the following roads from 8pm to 6am.

A452 northbound: 24 November to 25 November (one overnight closure)

A446 northbound: 14 December to 15 December (one overnight closure)

We have planned overnight lane closures

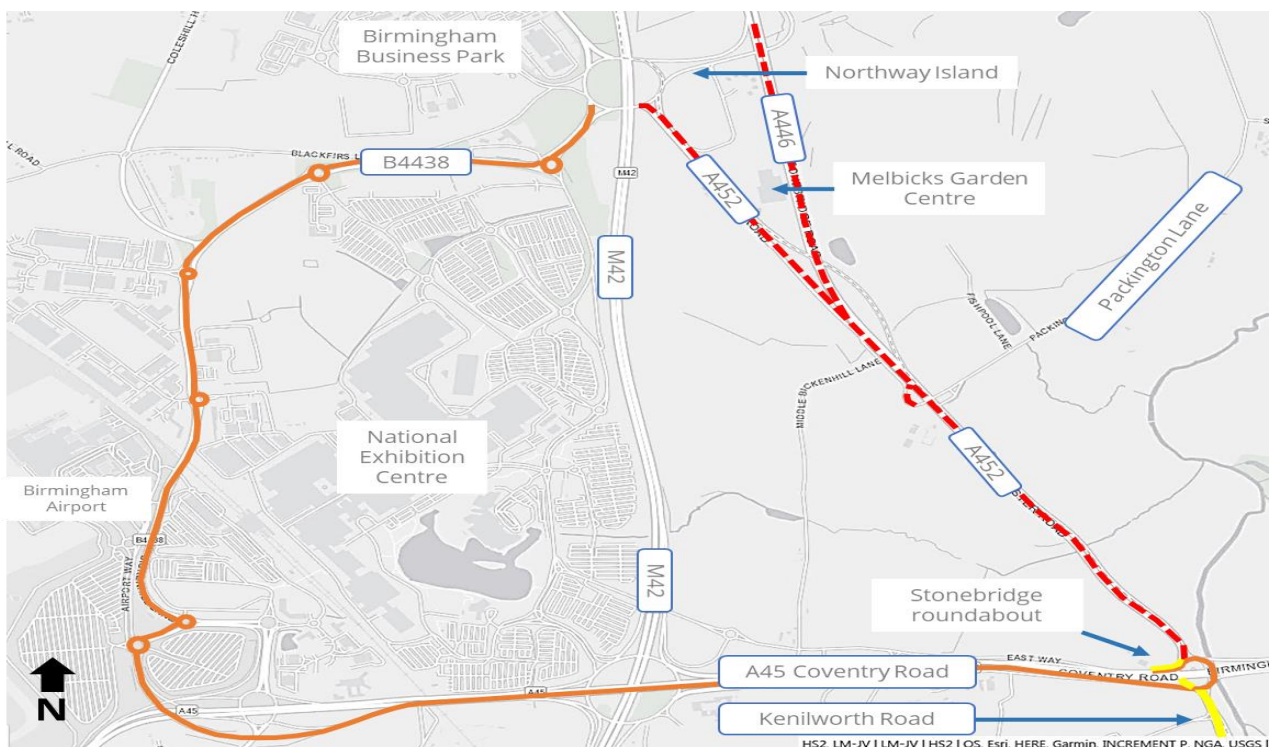
We will carry out overnight lane closures on part of the A452 Kenilworth Road northbound, leading up to Stonebridge roundabout, from 24 November to 25 November, 8pm to 6am.

Our 24/7 lane closures will be extended on the following roads.

A452 northbound: 17 September to 25 November (24 hours a day)

A446 northbound: 17 September to 15 December (24 hours a day)
