Notice of weekend part-closure of the A452 (n/b) and A446 (n/b and s/b)

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM. In your area, we are working near the A452, A45 and M42, which surround the site of the future HS2 Interchange Station.

We're improving the local road network

To ensure that the local road network is fit for purpose when the Interchange Station is operational, we are expanding and improving the existing network and creating new routes on HS2 land. To link the new network with existing routes, we're building four connecting highways bridges. The first of these bridges, spanning the M42, was successfully installed in August 2020. To safely install the next bridge deck over the A446, we will close sections of the A452 and A446 for one weekend.

We'll be starting work on Friday 23 October

Sections of the **A452 Chester Road (northbound) and A446 Stonebridge Road (northbound and southbound) between Stonebridge Island and M6 Junction 4 will be closed to traffic after evening rush hour on Friday 23 October 2020, and reopen before morning rush hour on Monday 26 October 2020.**

From Friday 23 October to Monday 26 October.

What to expect

We will temporarily close sections of the A452 Chester Road (northbound) and A446 Stonebridge Road (northbound and southbound) between Stonebridge Island and M6 Junction 4.

If our work progresses faster than expected, we will reopen both roads earlier if possible.

What we will do

Keep all sites safe and secure.

Ensure clear diversion signage is in place for drivers.

Provide free vehicle recovery along the planned diversion routes.

Leave the area in a tidy state when works are complete.


